Please note Article 4.01 (j) provides that "no Improvement other than a Dwelling Unit shall be constructed upon a Lot except (i) in conjunction with construction of a Dwelling Unit, or (ii) after a Dwelling Unit has been completed." Lot Owners are required to be in compliance with all of the provisions contained in the Declaration. You received a copy of the Declaration at the time you purchased your Lot. If needed, an additional copy may be obtained from the Architectural Control Committee. Feel free to submit any other material (photographs, sales literature, catalog pages, etc.) that may help the Committee in making an evaluation.

First, submit a PRELIMINARY ACC form to the ACC for review of your development plan and keep a copy of your submitted ACC form. **Do not apply for the Travis County Permit until the ACC reviews and approves your Development Plan. When the permit is obtained submit a FINAL copy of the ACC form with a copy of the permit AND any plan changes for final ACC approval before starting construction.**
